## Rezidor to manage Hotel Rezydent in Sopot, Poland

Today, in addition to beaches, the city includes a lovely boardwalk, numerous museums, and Europe’s longest wooden pier which stretches over 500 meters into the Baltic Sea.

Poland is one of Rezidor’s key development markets in Eastern Europe, where both of the company’s core brands Radisson Blu and Park Inn by Radisson enjoy an excellent reputation. The group’s portfolio across the country currently comprises 8 hotels with a total of 1,594 rooms in operation and under development.
